FOR THREE-YEAR-OLDS Colts and Geldings, 121 lbs.; Fillies, 116 lbs. By subscription of \$300, \$2,500 to enter and \$2,500 additional to start. Supplementary nominations may be made at the time of entry Wednesday, March 18, 2009 by payment of \$30,000 each (includes entry and starting fees). \$500,000 Guaranteed. After payment of 1% to all owners of horses finishing 7th through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second; 10% to third; 5% to fourth; 3% to fifth and 2% to sixth. The maximum number of starters for The Lane's End will be twelve. In the event more than twelve pass the entry box, the twelve starters will be determined at that time with preference given to Graded / Group Stakes winners in order (I-II-III), Stakes winners, then highest career earnings. In no event will starters be added or allowed to run which are not determined to be starters at the closing of entries. Starters and riders must be named through the entry box by the usual time of closing. Subscription fees may be paid with subscription or at a later date when invoiced. NOTE: All Lane's End nominees are automatically nominated to the \$100,000 Guaranteed John Battaglia Memorial to be run Saturday, February 28, 2009. Lane's End nominees are also automatically nominated to the \$100,000 Guaranteed Rushaway and the \$50,000 Guaranteed Hansel to be run Saturday, March 21, 2009.
